What to Report

1. Do we need to file a report if we **DID NOT** use pesticides at any schools or child care centers?

No. You do not need to file a report if you did not use pesticides at schoolsites.

2. Do we report the diluted amount or the undiluted amount of pesticide?

If you dilute a concentrate, report the amount of concentrate used.

If you do not dilute a concentrate, report the amount of actual product used.

3. If a school-site also has a child care on site and a pesticide is applied to the entire property, should I mark both the school box and the child care box on the form?

Both boxes should be marked in this situation.

4. Do we have to report herbicide/fungicides used on turf areas?

Yes. Report any pesticide applications on turf areas/athletic fields on schoolsite property.

5. I made a pesticide application that is exempt from some of the HSA regulations under Education Code §17610.5; do I have to report this application?

It depends.

If you are a schoolsite or district employee, you do not need to report applications that are exempted under §17610.5.

If you are a pest control business and not a schoolsite or district employee, you must report any applications of any pesticide with an EPA Registration number used at a schoolsite.

6. Do we have to report applications of FIFRA 25(b) minimum risk pesticides?

No. Pesticides exempt from state and federal registration are not necessary to report.

How and When to Report

7. What form is used to report a pesticide application at a California schoolsite?

Businesses/Contractors use form [DPR-ENF-117](#).

Schoolsite/District staff use [DPR-HSA-118](#).

8. Should I send page 1 and 2, or just page 1?

You only need to submit page 1 of the form to meet the reporting requirements.

9. How often do I need to send in the reports?

You only need to submit this report once a year. The report is due January 30th for the previous year. There are no monthly deadlines.

10. Can we submit the report online?

No. Currently we only accept reports via the mailing address.

Reporting Monthly/Scheduled Applications

12. Can I put “monthly” in any box on the report? We do regular pesticide applications monthly.

No. Each line of the report is used for a single pesticide application, so writing “monthly” in any box will cause the report to be flagged as an error. Errors often result in a request to resubmit records.

13. If we do regular monthly applications at the same location, is one form used or is it a separate form for each month an application was done?

Each line of the report is used for a single pesticide application. If you apply at one location monthly, you will have to fill out 12 lines on the reporting page, one for each monthly application. You do not need to organize the reports in any particular way, but if it is easier for you to fill out the forms by school or by month, that is not a problem.

Distinguishing the HSA reporting from the County Agricultural Commissioner Monthly Summary

14. Is there a different procedure for HSA reporting than online county submissions?

Yes. This report is independent of the county agricultural commissioner monthly summary reports. Schoolsite employees who do not use restricted use materials generally do not need to report to the county agricultural commissioner.

15. Should we send our school pesticide use reports with our county reports, or send directly to DPR?

Please send school PUR reports directly to DPR. The address for submitting the reports is on the bottom of the reporting form. See question 11.

16. Do we still have to submit monthly reports to the county?

Yes, if you are required to submit pesticide use reports to your county agricultural commissioner the school pesticide use report cannot be used as a substitute.

17. Does reporting application volumes on the school PUR form mean they do not have to be included in my monthly summary report to the county?

No. If you need to report pesticide use to your county agricultural commissioner, do not change the monthly summary report in any way to compensate for Healthy Schools Act reporting.

Reporting (Miscellaneous)

18. Do we need a chemical usage stamp?

No. This program does not use chemical usage stamps.

19. Do you just need a list of the pesticides that were applied at public schools?

No. This would not be considered a complete report. The Healthy Schools Act requires specific details of each pesticide application at a schoolsite.

20. Is this something new for 2016 or is the expectation that you receive this report for 2015?

Schoolsite pesticide use reporting has been the law for pest control businesses in California since 2002.

Schoolsite/district staff pesticide use reporting began in 2015. The first annual deadline for reports from schoolsite staff was January 30th, 2016.
